The Defense Investigator Training Academy (DITA) program consists of four modules targeting specific core topics essential to criminal defense investigation. Each module is comprised of forty hours of classroom and laboratory instruction followed by a final written examination.

Students must complete all four modules of training and pass rigorous written examinations at each module in order to complete the full course. Upon completion of all four modules, the student will receive accreditation as a Certified Criminal Defense Investigator (CCDI).

The program is sponsored and accredited by the California Defense Investigators Association. The instructor of record is Ron Weber, JD., Chief Investigator, Tulare County Office of the Public Defender.
